



Leaving an enduring gift to Big Buddy in your will

How your generosity will change fatherless boys' lives



Who we are and what we do

Big Buddy is a mentoring service that recruits positive male role models to mentor fatherless boys aged between the age of 7 and 14 years. This secular service is run by dedicated professionals who rigorously screen men from the community to become the father figures missing from these boys' lives.

This award-winning programme covers the Auckland, South Auckland, North Shore/Rodney, Hamilton and Wellington regions, with expansion plans for the rest of New Zealand.

Begun in 1997, Big Buddy became a registered charity in 2002. It is governed and supported by the Big Buddy Mentoring Trust and the Big Buddy Foundation.

The mentoring programme works on the simple philosophy that boys need positive male role models in their lives to reach their full potential. While mothers and grandmothers do a courageous job of raising their boys without a father figure, mums can't 'model' maleness. Quite simply, boys learn about being a man by being around other men.

The statistics on positive mentoring are clear and compelling. It's about making a world of difference, one 2-3 hour visit at a time. The idea is simple but profound. Research shows that for a boy growing up without a father, the benefits to having a Big Buddy include:

- a marked improvement to boys' confidence overall
- an increased feeling of general happiness in boys' lives
- a willingness to go outside their comfort zone and try new things
- an improvement in ability to relate to others

Big Buddy does not replace fathers. In the rare event that a boy does have a father present, we carefully establish how much contact they have and will only get involved if the contact and input is minimal, and if we have the father's consent.

My father passed away when I was 9. I was the youngest of three and my mother had to face the stark reality of being a solo parent.

I was fortunate to have an extended family including many uncles who took me under their collective wings and, along with my mother, they helped guide me through the next 6+ years.

Not all solo mums are this fortunate. There are often no adult males who are able to assist. Big Buddy is able to fill this gap by providing carefully selected mentors to fatherless boys. Our mentors are always fully trained and have proven to be good male role models in the boys' lives, giving them a helping hand and guiding them through their formative years. Over many years, research shows that young boys who have good quality fathering, or if that is unavailable, mentoring, fare very much better in all walks of life. This applies to both growing up and throughout adulthood.

Any gift or donation is a great help to us in our work. In particular, a gift in your will is, by its very nature, future



Leaving your legacy: important considerations

A bequest is a powerful gift. It has the potential to change lives and, at Big Buddy, we understand the value of this gesture. Please know that regardless of the amount, every gift is deeply appreciated and will be well-utilised. Your gift will go towards making more matches and changing outcomes for fatherless boys.

The Big Buddy programme's running costs are approximately \$700k per year. With about 9% of our funding coming from Government, we rely on the generosity of funders, sponsors and donors to support our work. The more funding we get, the more matches we make and the demand is high.

You have no obligation to tell anyone what decisions you have made in your will - it's your choice who you share your decision with. But knowing about bequests intended for Big Buddy will help us plan for the future. You can even talk to us about how you would like this important gift to be used. If you advise us of your 'Living Bequest', we are happy to acknowledge it publicly (if you so wish) and will ensure you are on our invitation list for appropriate events.

When making a will, or changing an existing one, it is safest to consult a solicitor or Trustee Company who is experienced in wills and estates.

If you already have a will, you should be able to include a bequest to Big Buddy; even after you've made your will, your are free to change it at any time.

Types of Gifts you can leave in your will

There are three main types of gifts to consider - you can choose a bequest that best reflects your wishes:

 Residual Gift: This means leaving the remainder (or percentage thereof) of your estate to Big Buddy after your loved ones have been looked after and any expenses deducted.

- Pecuniary bequest/Fixed sum: This gift is in the form of a specified cash amount e.g. \$10,000.
- Percentage Bequest: This is used if you wish to divide your estate among a number of people or organisations. Leaving your gift as a percentage rather than a fixed amount will ensure that inflation doesn't erode the value of your gift over time.

How to bequest and support the Big Buddy Foundation

If you do not have a will or wish to make a new will, the Big Buddy Foundation is partnering with Perpetual Guardian as a part of an initiative to ensure that every New Zealander has a will and every child is protected by an Estate Plan. With over 130 years experience Perpetual Guardian specialise in and is dedicated to providing wills to New Zealanders. As a part of it's social responsibility agenda Perpetual Guardian provides a will service to their charitable partners at a reasonable cost so that people can consider a charity in their will, once they have looked after their family and friends.



Wording Suggestions

It's important that your bequest is worded correctly, and we have supplied the following two examples as a guide. You can consult your solicitor, Perpetual Guardian Trust, another trustee company or the Public Trustee regarding the wording.

Outright Gift


FOUNDATION (CC50456). Without imposing a binding trust, I ask that these funds be used for the benefit of ______. A receipt appearing to my Trustee to be given on behalf of the Foundation will be a complete discharge to my Trustee for the gift.

I give [INSERT AMOUNT] to THE BIG BUDDY

Remaining Estate

I give [the rest of] my estate to my Trustee on trust. Out of this my Trustee will pay my debts, all funeral, memorial and estate administration costs and all taxes payable on my estate.

My Trustee will transfer what remains of my estate ("my Remaining Estate") to THE BIG BUDDY FOUNDATION (CC50456). A receipt appearing to my Trustee to be given on behalf of the Foundation will be a complete discharge to my Trustee for the gift.
